This course covers the most widely used software packages while providing students hands-on experience with current computer applications. Prior knowledge of Windows is strongly recommended. Assessment Level(s): AELW 940/ELAI 990 or ENGL 101/ENGL 101A,MATH 050, READ 120. Three hours each week. Formerly CA 120. 3 semester hours

May not be taken concurrently with MATH 017 or MATH 020 or MATH 045 without appropriate Math assessment score
